1. In and around the human body there are electromagnetic oscillations. These electromagnetic oscillations are superordinate to the biochemical processes and control them.
2. As well as the physiological electromagnetic oscillations, there are also pathological interfering oscillations in every person, caused for example by toxin loads, injuries, infections, incompletely cured diseases, iatrogenic damage.
3. The physiological and pathological oscillations together are referred to as the patient's own oscillations.
4. The patient's own oscillations can be picked up from the surface of the body (antenna effect) and conducted through a lead into a therapy device.
5. Therapy oscillations are made from the patient's own oscillations with the aid of modern electronics, without adding other or technically generated frequencies.
6. The patient's own oscillations transformed into therapy oscillations are fed back from the Devita BRT device to the patient's body. The therapeutic effect does not take place in the therapy device but in the body of the patient himself.
7. The therapy oscillations cause a therapeutic effect in the patient's body firstly by suppressing or reducing the pathological oscillations and secondly by exciting or strengthening the physiological oscillations.
8. The aim of bioresonance therapy is to reduce or eliminate the pathological oscillations and at the same time strengthen the physiological oscillations.
9. Improvements at the biophysical energy level are followed in time by an improvement in the biochemical processes in the direction of normalization or healing.



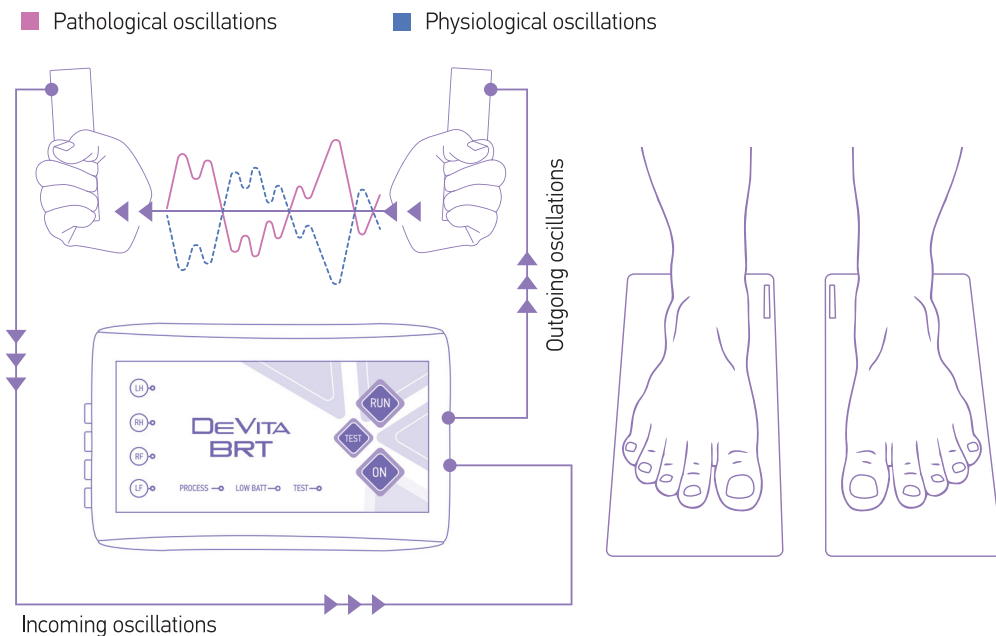

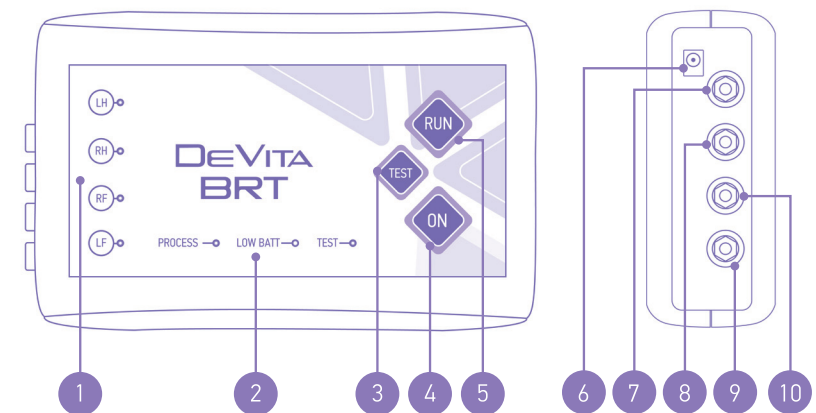

## MECHANISM OF ACTION

The device is based on the development of F. Morell and E. Rush. In 1977 in Germany, they proposed a new biophysical method for BRT. For the development of the method the experience of a doctor and an engineer was combined for the first time. BRT is a method of endogenous bioresonance correction using our own ultra-thin electromagnetic signals of the human body. This is a promising method of correction, contributing to the restoration of the body's defences and adaptation reserves by enhancing the harmonic (physiological) and weakening the disharmonious (pathological) electromagnetic oscillations of a person.



## HOW IS THE DEVICE BUILT:



1. Indication of connected leads.
2. Status indication («PROCESS» - the procedure being performed, «LOW BATT» - low battery, «TEST» - «Test» mode).
3. «TEST» - button for switching on the «Test» mode.
4. «ON» - the power button for turning on / off the device.
5. «RUN» - button for switching on the «Session» mode.
6. Connector for connecting a regular network adapter.
7. Connector (LH) for connecting the left hand cylindrical electrode.
8. Connector (RH) for connecting the right hand cylindrical electrode.
9. Connector (LF) for connecting the left plate foot electrode.
10. Connector (RF) for connecting the right plate foot electrode.
